	La Boîte à soleil  Opened their 7 <sup>th</sup> centre in February at Burleigh Hill, there was a separate existing structure on the property. They are not at full capacity yet, are working toward it.		
	<ul><li>Strive Niagara</li><li>Just opened a before and after school program on Fitch Street.</li><li>It's been a great partnership.</li></ul>		
	<ul> <li>A Child's World</li> <li>St. Elizabeth's is slated to be torn down, they have moved that centre to Webb. It will hopefully open in September.</li> <li>Tiny Travellers - \$10 year in rent was changed to market value - \$160,000/year. This would come from the funding pot, which may affect others' funding. Kim met with Jennie Stevens about the issue and she took it to Queen's Park and asked the Minister of Infrastructure to overturn the decision.</li> </ul>		
	<ul> <li>Grimsby Community Preschool</li> <li>We are expanding on our current property. There are 2 other houses on the land, and the church has offered it to GCP. The church can apply for re-zoning. The new location will have longer hours as that is a need they are seeing.
